MEETING: This is the yearly meeting of the Inland Empire Rifle and Pistol Association. Important decisions are made about the Spokesman-Review Postal. Come and let your voice be heard.

RULES: NRA Smallbore rifle and pistol rules will govern. Smallbore rifle rule 3.2 and any sight rule 3.7 and pistol rule 3.4.

ELIGIBILITY: Any NRA member of a club, which is competing in the 2007 Spokesman-Review postal league. Jr. Shooters welcome on A-17 targets.

ENTRIES: Entries will be on a first come, first serve basis. Limited to 16 per relay. Two relays each discipline. Advanced entries for both rifle and pistol matches will be given relay preference.

FEES: Across the board entries for all the matches will be \$18.00. Rifle ONLY will be \$10.00. Pistol ONLY will be \$10.00. The team fees will be \$2 extra for each member.  
This match IS NOT NRA approved.

CHALLENGE FEES: Challenge fee will be \$3. Challenge must be made within one hour from the posting of the scores.

\*\*\*SQUADDING: The First relay for RIFLE will begin at 8:30 a.m. The Second RIFLE relay will begin at 10:00 a.m. The ANNUAL MEETING will begin at 12pm. The First PISTOL Relay will follow the meeting. Tentatively: If enough additional participants sign up - a Second PISTOL Relay will be held after the first.

CLASSIFICATION: The current NRA classification will be used. Unclassified shooters will be placed in the Master Class. IF less than two shooters are in a class, they will be combined with the next higher class.

Appropriate AWARDS will be given to the winning Seniors and Juniors.

BULLETIN: All competitors will receive a Match Bulletin.

(Juniors may elect to shoot kneeling or standing in place of sitting)

TEAM MATCH: A 2 member team match in both rifle and pistol will be held. Scores for the team match will be the scores fired in match #7 for PISTOL and first stages of matches #1, 2, 3 and 4 for RIFLE. Entries must be made before the firing of match #1 for RIFLE and before firing match #7 for PISTOL. A member must enter the team match under the club they are shooting the postal tournament for that year. Fee will be \$2 per shooter. The winning team in each discipline will have their names engraved on a perpetual plaque.
